The Truth in Taxation Law (35 ILCS 200/18-55) requires local taxing districts to provide transparency and accountability when levying property taxes. If Sauk Valley Community College's proposed property tax levy exceeds the previous year's extension by more than 5%, the College must publish a notice of the increase in a local newspaper and hold a public hearing. The notice must include last year's extension, the proposed levy, and the percentage increase, and it must be published 7 to 14 days before the hearing. A public hearing provides an opportunity for community members to comment on the proposed increase before final adoption. The final levy must be adopted and submitted to the county clerk by the statutory deadline. A certificate of compliance must also be filed, affirming that all Truth in Taxation requirements have been met.

The estimated tax levy for taxy year 2024, along with a comparison to the taxy year 2023 extensions is as follows:
