#### **Presentation:**

The Information Technology Services area on the second floor has become outdated and is in need of renovation. Deterioration, especially from water leaks, has caused visible damage, affecting the functionality of faculty and staff office spaces along the hallway in the West Mall. The 2024/25 Abatement and Renovation Project aims to not only address this issue, but also provide a modernized layout better suited to the evolving needs of faculty and staff, creating a more efficient and welcoming work environment.

The award recommendation and official bid tabulation form prepared by Willett Hofmann and Associates, Inc. for the abatement phase of this project is included.

Restricted use Funding Bond Proceeds.

#### Dear Kent:

Proposals for the SVCC 2024/25 Abatement Project – 2nd Floor were opened at 10:00 AM on Monday, November 11, 2024. The project was publicly advertised on October 28, 2024 and eleven (11) contractors and one (1) plan room requested and were provided bid documents. Seven (7) bid proposals were opened and read aloud. Another bid packet was duly received by the SVCC Business Office prior to the designated time for the bid opening. However, due to an inadvertent oversight, the bid was not opened at the scheduled hour. Once the issue was identified, the bid was promptly opened and witnessed by the College and is also included on the attached bid tabulation. The bid package requested a Base Bid and an informational bid item. Following review of all bids received the low bidder was Colfax Corporation of Chicago, Illinois with a bid proposal of One Hundred Thirty Seven Thousand Seven Hundred Fifty and 00/100 Dollars (\$137,750.00).

#### **RECOMMENDATION**

The low bidder was interviewed by phone, and the scope of work, material quantities, project schedule and project procedures were discussed. Based on the information obtained during phone interviews with the Contractor, we were assured that the complete scope of work has been included in the bid proposal and that the Contractor has the experience, capability, forces and equipment to competently and completely perform the work per the requirements as specified on the Drawings and in the Project Manual.

Therefore, based on the information stated herein, it is recommended that Sauk Valley Community College award the SVCC 2024/25 Abatement Project – 2nd Floor to Colfax Corporation of Chicago, Illinois with a bid proposal of One Hundred Thirty Seven Thousand Seven Hundred Fifty and 00/100 Dollars (\$137,750.00).
