President's Report: Dr. David Hellmich acknowledged the recent passing of former

Adjunct Instructor, Ronald Meyer, who taught HVAC courses at

Sauk from 1993 – 1999.

Dr. Hellmich congratulated the Spring 2024 retirees Noel Berkey, Bridget Burren, Jane Grove, Pamela Medema, and Jane Verbout. Dr. Jon Mandrell introduced Noel Berkey, who began at Sauk in 1991 and has taught over 6,000 students during that time, Bridget Burren, who has been tutoring students at the College since 2008, and Jane Verbout, who has also been at the College since 1991 and has tutored thousands of students giving extra help at finals time hosting pizza parties and more. Joe Strabala-Bright introduced Pamela Medema, the longest serving Registrar in the history of Sauk who helped bring the one-stop Student Services shop to fruition. Joe concluded by honoring Jane Grove, who will be remembered for her calm demeanor, her compassion, and her thoroughness when completing her work.

Dr. Mandrell presented faculty members who participated in the recent study abroad trip to Pakistan. Dr. Paul Edleman reported on the ten-day trip and invited each participant to share their stories. Paul spoke of the cultural components of Phoor Nagar Village and its rural environment. Dr. Amy Jakobsen learned about the history and culture from the curious people she encountered along with the ceremonial and hospitable atmosphere. Janis Jones was moved by the protocol, the red-carpet treatment and being treated as a distinguished academic guest while conducting workshops for students and teachers. Glenn Bodish was grateful for the incredible opportunity and the deep and meaningful connections while meeting with faculty and students. Paul concluded by thanking the administration and trustees for allowing them to travel to Pakistan.

Chloe thanked everyone for allowing her to serve on the board this past year.

Foundation Report: Dr. Lori Cortez reported kicking off a small-town campaign in Ashton-Franklin Grove where the Impact Team will hold two kickoff events for the \$600,000 campaign. Lori mentioned the most recent Points of Pride: the recent successful Sonography Program's first information meeting; the more than 130 students signed up so far for the Impact Program; and the 2024 Distinguished Alumnus of the Year, Bob Sondgeroth, and the 2024 Rising Star Alumni awardee, Karli Ewaniuk.

ICCTA Report: Chair Bob Thompson reported he will be in Springfield soon for Executive Committee interviews and reminded others of the ICCTA Lobby Day on May 2 in Springfield.

Dr. Hellmich reported that Chair Thompson recently was honored by ICCTA with his third Trustee Education Award for his participation in 45 or more seminars offered by ICCTA.
